### **Job Outline**

The role of a Maingrade Educational Psychologist within Golden Thread Psychology is to deliver an educational psychology service to children, young people and families who access a range of educational settings that purchase Golden Thread Psychology services.

### **Role Responsibilities**

- To deliver responsive Educational Psychology services for children and young people (0 – 25 years), families and a range of educational settings, working within the established service delivery model, to facilitate the support of positive outcomes for vulnerable pupils and those with Special Educational Needs.
- To contribute towards the development and delivery of a range of assessments and interventions for educational settings, promoting evidence-based practice to improve outcomes for children and young people.
- To work collaboratively with other agencies to deliver support and services, coordinated and built around the needs of children, young people and their families.
- To maintain accurate and up-to-date work records that are easily understood, and to make these available to all those who should have access to the information.
- To engage with Continuous Professional Development (including professional supervision and team meetings), at least to the level requires by appropriate professional associations.
- To contribute to Golden Thread Psychology team development and training.
- To implement the required policies of Golden Thread Psychology, working within appropriate legislative frameworks.
- To promote Golden Thread Psychology's values of connection, clarity, curiosity and community.
- To work within and promote equal opportunities in terms of ethical, moral and legislative frameworks.

- To work within the codes of conduct of the Health and Care Professions Council (HCPC) and the Division of Educational and Child Psychology (DECP) of the British Psychological Society (BPS).

#### **Position in the Organisation & Key Relationships**

The role of a Maingrade Educational Psychologist is that of an employee within Golden Thread Psychology. Maingrade Educational Psychologists sit beneath the Lead Educational Psychologist and report to the Lead Educational Psychologist.

#### **All staff are required to**

- Ensure that they are approachable and that their conduct towards colleagues is open and honest, dealing with differences in opinion in ways which avoid offence.
